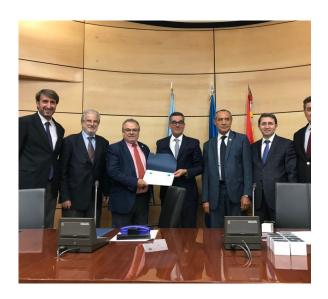

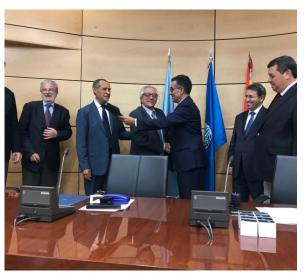

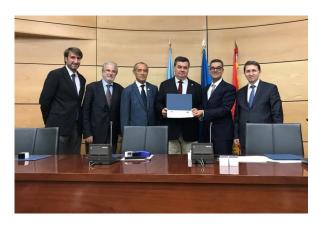

AUSTRALIA - IMPORTS OF OLIVE OIL

Australia has a total area of $7\,741\,220\,\mathrm{km^2}$, an estimated $35\,000\,\mathrm{of}$ which has been devoted to olive growing. The Gross Added Value of agriculture represents 2.52% of GDP. The population stands at $24\,450\,561$ people, 10.35% of which live in rural areas. Life expectancy is 82.5 years and the number of children per woman is 1.76.

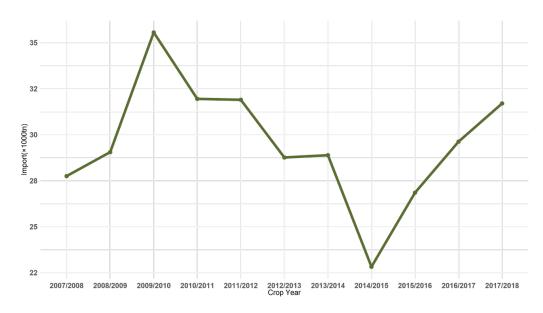

1.0live oil and olive-pomace oil

Australia's imports of olive oil and olive-pomace oil increased by 7% in the 2017/18 crop year. Some $31\,699\,t$ were imported, an increase of 10.2% if we compare with the 2012/13 crop year, which saw imports of $28\,762\,t$. Table I shows changes in imports over the last 6 crop years: the minimum was reached in the $2014/2015\,t$ crop year, coinciding with the year with the lowest gross national income per capita (2015). On the other hand, Spain and Italy are Australia's main suppliers, accounting for 89.9% of the total, followed by Greece with 4.4% and the rest of the countries with less than 2%. The largest increases in the $2017/18\,t$ crop year occurred in Lebanon and Spain (47.7% and 12.7%, respectively) compared to the previous crop year. By origin of imports, 94.6% of the total came from the European Union. The remaining 5.4% comes mainly from Turkey 1.9%, Lebanon 1.4% and Tunisia 1.1%.

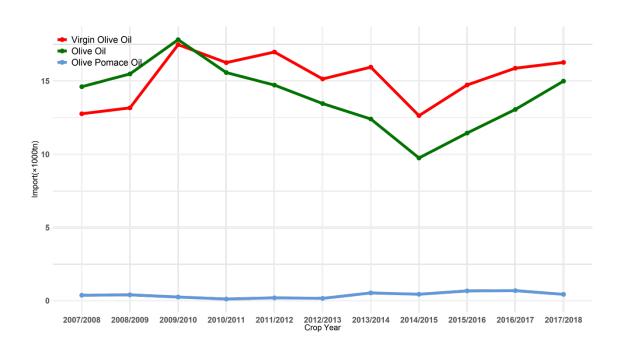
As for volumes by product category, 51.3% of total imports were under code 15.09.10 (virgin olive oils), followed by imports corresponding to code 15.09.90 (olive oils) with 47.3% and the remaining 1.4% corresponding to imports under code 15.10.00 (olive-pomace oils).

Trends in imports of virgin olive oils and olive oils have changed since the 2014/2015 crop year. Imports of virgin olive oils increased by 27.5% if we compare the 2017/2018 crop year with the 2007/2008 crop year, when they represented 46% of total imports.



■ Graph III - Evolution of imports by product type 2005/06 - 2017/18 (×1000 t)

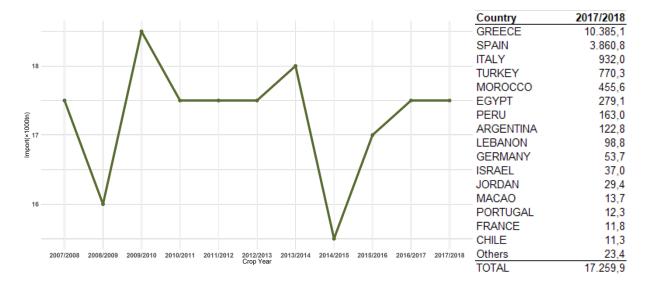

2. Table olives

Australian has imported around 17 000 t of table olives in the last 11 crop years, reaching 17 259.9 t in the 2017/18 crop year (September 2017 - August 2018), or 2.7% of world imports.

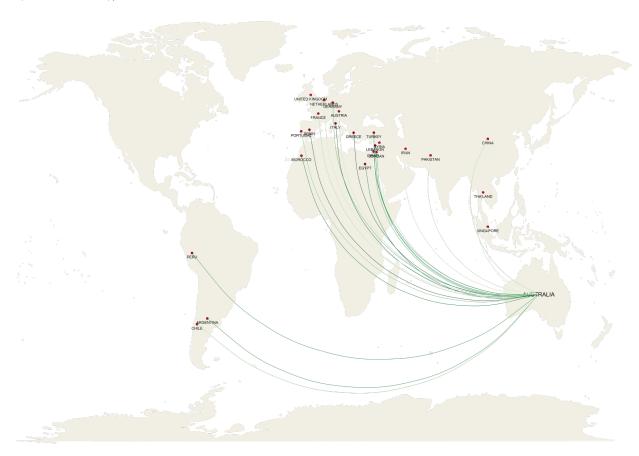
Table II shows the imports of the last crop year by country of origin. Greece stands out as the main supplier to Australia, with 60.2% of the imported volume (10 385.1 t), followed by Spain with 22.4% (3 860.8 t) and Turkey with 4.5% (770.3 t). The rest of the countries are below 3%. In section I.2 of this publication you can follow the monthly movements of this market.

I. WORLD TRADE IN OLIVE OIL AND TABLE OLIVES

1. OLIVE OIL - 2018/19 MARKETING YEAR

The table below shows trade figures for olive oil and olive-pomace oil in the top eight markets in the first ten months of the current crop year (October 2018 – July 2019). Increases were found in Japan (23%); Russia (14%); Brazil (13%); China (12%); the US (9%); Australia (3%); and Canada (1%) compared to the same period of the previous crop year.

In the first nine months of the current crop year, intra-EU purchases increased by 5% and extra-EU imports decreased by 11% compared to the same period of the previous crop year¹.

2. TABLE OLIVE - 2018/19 CROP YEAR

The table below shows trade in table olives in the first eleven months of the 2018/19 crop year (September 2018 - July 2019)². Increases were found in the US (18%); Australia (8%); Brazil (7%); and Canada (2%) compared to the same period of the previous crop year.

In the first ten months of the 2018/19 crop year (September 2018 – June 2019), intra-EU acquisitions rose by 2% and extra-EU imports remained stable compared to the same period the previous crop year³.

II. PRICES IN ORIGIN - OLIVE OILS

Graph 1 shows the weekly producer price movements of extra virgin olive oil in the top three producer countries of the EU and Tunisia. Graph 3 shows the weekly producer price movements of refined olive oil in the top two producer countries of the EU. Price movements by month can be found in graphs 2 and 4.

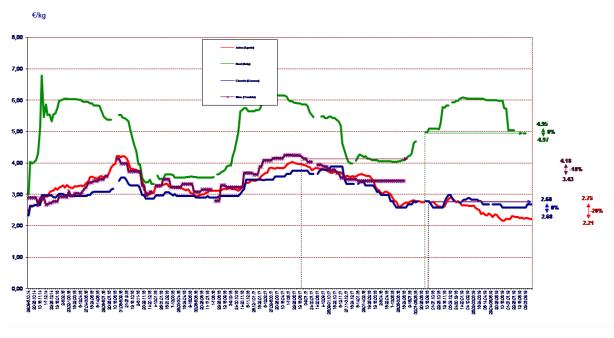
Extra virgin olive oil – Producer prices in **Spain** in the third week of August stood at €2.21/kg, an 20% fall compared to the same period the previous crop year (Graph 1).

Italy – Prices in Italy in the second week of July 2019 stood at €4.95/kg, so they remain stable compared to the same period the previous crop year.

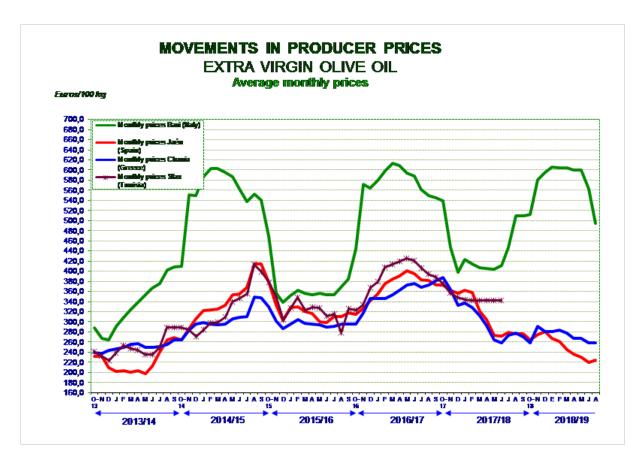
Greece – Prices in Greece in the second week of August 2019 stood at €2.68/kg, so they remain stable compared to the same period the previous crop year.

Tunisia – Prices in Tunisia were stable in the last weeks of June 2018, coming in at €3.43/kg, an 18% fall compared to the same period the previous crop year.

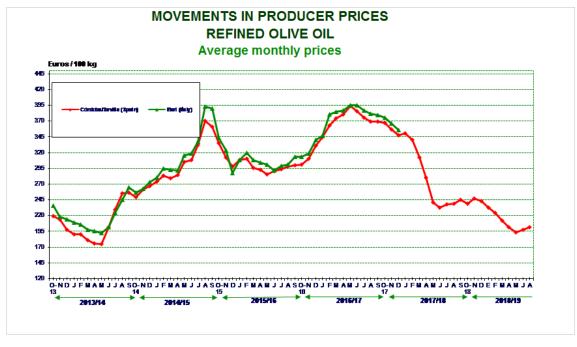
Refined olive oil - Prices in Spain stood at $\pounds 2.03$ /kg in the third week of August, a fall of 18% compared to the same period the previous crop year. Data for Italy have not been available for this category since late December 2017, when they had risen by 4% to $\pounds 3.56$ /kg.

By the third week of August 2019, the price difference in Spain between refined olive oil (€2.03/kg) and extra virgin olive oil (€2.21/kg) was €0.18/kg. In Italy, the difference in December 2017 was €0.43/kg (see Graph 3).
