# COLLABORATION AGREEMENT SIGNED WITH LIBYA

**Madrid** - A collaboration agreement was signed between the International Olive Council and Libya during the World Olive Day celebrations at IOC headquarters on 22 November. The agreement was signed by the Executive Director, Abdellatif Ghedira, and by the chargé d'affaires of the Embassy of Libya in Madrid, Walid B. D. Abuabdalla. The agreement, which was approved by IOC Member States, aims to develop and support the olive sector in Libya, in particular by creating two laboratories, one for the physico-chemical testing and another for the organoleptic assessment of virgin ol-

ive oils, and by keeping up with their activities.

The Executive Secretariat of the IOC will watch over the training programmes of qualified staff, through the Olive Growing, Olive Oil Technology and Environment Unit and its Technical Cooperation and Training Department. Regular meetings will be organised at IOC headquarters to monitor the activities carried out in Libya by the IOC. The agreement was sealed with an official handshake between the two representatives (pictured) in the presence of authorities, the diplomatic corps, members and delegations of the IOC on World Olive Day, which was celebrated as part of the 108th session of the Council of Members.

# GEORGIA ANNOUNCES ITS INTENTION TO BECOME A MEMBER OF THE IOC

**Madrid** - The Executive Director of the International Olive Council, Abdellatif Ghedira, recently welcomed the Ambassador for Georgia to Spain, H.E. Ilia Giorgadze, who was accompanied by the owner of the largest olive-growing company in the country, George Svanideze.

The Ambassador informed Mr Ghedira that his country wished to join the IOC as soon as possible and that he wanted to know the conditions for entry. He said that, although Georgia was a small producer, it had an ambitious plan to improve both production and quality. Georgia currently produces a few hundred tonnes per year. He also mentioned that Georgia exports its olive oil to the United Arab Emirates.

Mr Svanideze, a leading partner in Georgian olive-growing, presented his plan to promote olive oil in the country. He works alongside farmers themselves: he encourages them to plant olive trees with the promise of buying all that they produce. He also plans to increase the olive-growing area of the country by more than 1000 hectares in 2019. Georgia's olive-growing area currently stands at 2 500 hectares.

The Executive Director explained the role of the IOC in developing and promoting the olive-growing sector and spoke about the advantages of membership for Georgia, in particular the expertise that the IOC can provide, training sessions for tasting panels, study grants, and access to global statistics and all other information relevant to the sector.





# THE IOC AT WORK TO SPREAD THE HEALTHY PROPRIETIES OF OLIVE OIL MADRID

**Madrid** - A meeting was held at IOC headquarters in Madrid with the recently-formed group of experts on the nutritional properties of olives and olive products. The group was comprised of Prof. Manuel Franco (University of Alcalá, Spain), Prof. Miguel Ángel Martínez González (University of Navarra, Spain) and Prof. Francesco Visioli (University of Padua, Italy). The aim of the group is to coordinate research in the sector, and to propose new research projects and events in order to foster and strengthen networks of academics working in the field.

The nutritional benefits of olive oil are one of the key factors driving olive oil consumption, especially in newer consumer countries where olive oil is often a lesser-known product. Scientific evidence has shown the positive properties of olive oil and how they have a hand in maintaining normal bodily functioning and in preventing a wide range of diseases.

The discussions focused on the need to conduct more interdisciplinary research into understanding the links between primary production and processing, olive and olive oil composition and the effect on human health. Collecting enough data on these three topics will improve knowledge about the benefits of olive oil consumption. For example, the official opinions given by the European Food Safety Authority (EFSA) are based on published scientific literature, which should prove beyond any doubt the causal link between a food product or a food component and their specific health benefits. Collaboration is therefore crucial to gathering enough data.

Following the meeting with Mercedes Fernández, head of the Standardisation and Research Unit, and Nicola Caporaso, head of the Chemistry and Standardisation Department, the experts met with the Executive Director Abdellatif Ghedira, who thanked them for their work. The experts were given an official certificate and a bottle of Mario Solinas Award-winning extra virgin olive oil.

The Executive Secretariat would like to thank the experts once again, and looks forward to collaborating further on research into the health properties of olives and olive oil.

#### I. WORLD TRADE IN OLIVE OIL AND TABLE OLIVES

#### 1. OLIVE OIL - CLOSE OF THE 2017/18 CROP YEAR

Imports in olive oil and olive-pomace oil at the close of the 2017/18 crop year (October 2017 – September 2018) increased by 29% in Brazil, 18% in Canada, 7% in Australia, 4% in Russia and 2% in the US. They remained stable in Japan compared to the previous year. Imports however decreased in China (-8%).

Figures for the EU closed 2017/18 crop year indicate that extra-EU imports increased by 84% and intra-EU acquisitions fell by 1% compared to the same period the previous crop year.

#### 2. TABLE OLIVE - CLOSE OF THE 2017/18 CROP YEAR

Trade in table olives at the close of the 2017/18 crop year increased by 9% in Canada, but fell by 4% in Brazil, 3% in the US and 2% in Australia compared to the same period the previous crop year. At the close of the crop year, EU figures show a 1% increase in intra-EU acquisitions and 15% increase in extra-EU acquisitions compared to the same period the previous crop year.



#### 3. OLIVE OIL AND TABLE OLIVE-ESTIMATED WORLD IMPORT (2018/19)

It is estimated that imports in olive oil and olive-pomace oil for the 2018/19 crop year will decrease by 6% compared to the previous crop year, to reach  $874\,500$  t.

The expected figures show that Extra-EU acquisitions will see an overall decrease of 33%. Furthermore, expected import of olive oil and olive-pomace oil at the close of the next 2018/19 crop year (October 2018 – September 2019) will increase by 5% in China and 2% in Brazil. They will remain stable in Australia, Russia and United States, compared to the previous crop year. Imports however will decrease in Canada (-8%) and Japan (-1%).

On the other hand, the expected figures for table olives at the close of the 2018/19 crop year will decrease by 2% compared to the same period the previous crop year, to reach 625 000 t.

#### II. PRODUCER PRICES - OLIVE OILS


Graph 2 tracks the weekly movements of prices paid to producers for extra virgin olive oil in the three main producer countries of the EU and in Tunisia. Graph 4 shows the weekly changes in producer prices for refined olive oil in the three main EU producer countries. Monthly price movements for these categories are given in Graphs 3 and 5.

**Extra virgin olive oil** - Producer prices in Spain have remained generally stable over the last few weeks coming it at €2,79/kg at the end of December 2018, which is a 22% decrease compared to the same period the previous crop year (Graph 1).

**Italy** - Production prices have passed the €5,0/kg mark at the beginning of September 2018, reaching €5.93/kg by mid-December 2018 which is a 49% year-on-year increase.


**Greece** - Prices fell slightly in the first week of December, coming in at €2.88/kg which is a 14% decrease compared to the same period the previous crop year.

**Tunisia** - Prices remained stable in the last weeks of June 2018, reaching €3.43/kg, an 18% decrease compared to the same period the previous crop year.



**Refined olive oil:** Producer prices in Spain came in at €2.41/kg by end-December 2018, a 31% decrease compared to the same period the previous crop year. Data for this category have not been available from Italy since the end of December 2017, when they reached €3.56/kg, a 4% increase compared to the same period the previous crop year. Data for this category in Greece are not available.


At the end of December 2018, the price difference in Spain between extra virgin olive oil (£2.79/kg) and refined olive oil (£2.41/kg) was £0.38/kg, while it was £0.63/kg in Italy according to data from December 2017 (Graph 3).
